The American Bar Association Model Code of Professional Responsibility, created by the American Bar Association (ABA) in 1969, was a set of professional standards designed to establish the minimum baseline of legal ethics and professional responsibility generally required of lawyers in the United States . It was replaced with the Model Rules of Professional Conduct in 1983 for a number of reasons, especially the Watergate scandal.
